II. Review and revise notes from prior meeting


- a. Additions to target groups (Minutes section IV(a)):
 - i. Faith based communities
 - ii. LGBTQ
 - iii. IV(a)(i): Parents of mid-high schoolers, PTA's, school staff, wellness counselors, school principals – because trafficking curriculum, neighborhood crime prevention councils

b. Additions to target goals:

i. Even though the conference is meant to help inform policy, it is important to use lay terminology at the conference so that people less familiar with trafficking can understand how trafficking is relevant in their lives.

c. Revisions to proposed dates:

- i. 3rd Week would not be good because public schools end May 27th, 1st week of May won't work because of another conference in Santa Cruz
