San Francisco Collaborative Against Human Trafficking Minutes

I. Welcome and Introductions

No agency announcements were made.

II. Presentation of Findings by SFSU MPH Students who Conducted an Assessment on Non-Sexual Trafficking in San Francisco

Three Masters in Public Health students presented information they have compiled while working with the Department of Public Health's Newcomer Health Program on non-sexual trafficking in San Francisco. The purpose of their research was to assess the support, barriers, and access to social, physical and mental health services for survivors of non-sexual human trafficking in San Francisco. In conducting their research, the students consulted existing literature on the subject and conducted interviews of direct service providers, law enforcement organizations and legal and advocacy organizations. Their findings and recommendations can be found on the accompanying attachment.

III. Presentation by Women's Funding Network

Next, the Program Officer from the Women's Funding Network presented information about the Network, which connects more than 165 organizations that fund women's solutions across the globe. Collectively, the Program's members invest \$65 million annually in women and girls worldwide and have over \$535 million in working assets. In the human trafficking arena, the Network helped fund a project called, "A Future, Not a Past," a statewide campaign to stop the prostitution of girls in Georgia. Specifically, the program sought to quantify the extent of the problem by first counting the number of adolescent girls exploited through the internet, escort services, street activity, and in major hotels, and then by counting the number of men who purchase sex with adolescents in Georgia each month. Next, the Program's members sought to come up with strategies to fund additional research, inform policy makers, convene stakeholder groups, provide information to media, and draw attention to technical tools. The Program is also beginning to be replicated in other states and cities.

The Network hopes to partner with SFCAHT in order to do some work around the Superbowl, which tends to be a weekend when sexual exploitation rises.
